# HBW FOODSERVICE – TERMS & CONDITIONS OF TRADE

- 1. Definitions 'Supplier' means HBW Foodservice. 'Customer' means the applicant identified in this agreement. 'Goods' means all goods and services supplied by the Supplier to the Customer.
- 2. Payment Terms Unless otherwise agreed in writing, payment shall be made within 7 days from the date of invoice. New customers may initially be placed on prepaid terms at the Supplier 's discretion.
- 3. Credit Approval Credit facilities are granted subject to satisfactory trade references and ongoing creditworthiness. The Supplier reserves the right to reduce, suspend, or withdraw credit facilities at any time.
- 4. Retention of Title Ownership of the goods remains with the Supplier until full payment has been received. Risk passes to the Customer upon delivery.
- 5. Personal Property Securities Act (PPSA) The Customer acknowledges that these terms create a security interest under the PPSA and agrees to sign any documents required by the Supplier to protect its interest.
- 6. Delivery Delivery dates are estimates only. The Supplier shall not be liable for delay or failure to deliver caused by circumstances beyond its reasonable control.
- 7. Claims & Returns Claims for shortages or damage must be made within 24 hours of delivery. Returns are subject to Supplier approval and may incur restocking fees.
- 8. Pricing Prices are subject to change without notice. The price charged will be the price current at the date of supply.
- 9. Privacy The Supplier collects personal information for the purpose of assessing credit applications and managing accounts. Information may be disclosed to credit reporting agencies and trade referees for these purposes.
- 10. Default If the Customer defaults in payment, the Supplier may charge interest at 2% per month and recover all costs incurred in the collection of overdue accounts, including legal fees.
- 11. Governing Law These terms are governed by the laws of Queensland, Australia.
- 12. Amendments The Supplier may amend these Terms & Conditions by providing 30 days ' written notice or by publishing the revised terms on its website.
